Provided effective Administrative Services support including air travel, road transportation, facilities management to support Programme Delivery.

#### **Output Analytical Statement of Progress:**

Continuous effort was made throughout the year to reduce operating costs. Installation of Solar Panel project was completed for UNICEF Myitkyina Office and 2954 kwh have been produced within 4 months' time of full operation and covering 90% of energy consumption during day time. Co-location at UNICEF Offices is being implemented: Co-location of premises in field locations has increased in 2019. Lashio Office is co-located with WFP starting from 1 July 2019; WFP is co-located with UNICEF in Hpa An staring from 1 May 2019; and ILO is co-located with UNICEF in Taunggyi starting from April 2019. UNICEF is co-locating with 14 other UN Agencies at UMFCCI Building in Nay Pyi Taw and provided the required support for readiness of work stations for the early movers. 10554 kWh of electricity consumption has been decreased in 2019 (Jan-Oct) compared to 2018 (Jan-Oct). Electricity Charges increased by 35% by the Government and there has not been much cost saving for electricity charges. Licenses for 20 Nos Satellite Phones were granted by Directorate of Telecommunications and UNICEF was able to take the opportunity to apply for the licenses when the Government released the restrictions on issuing legal licenses for UN organizations. Logistics supports to Executive Director's visit, NatComms' Visit, Regional Management Team Meeting, CRC@30 Day were provided. Two LTAs for Cleaning Services were established by UNICEF and shared with other agencies.

#### **Lessons Learned and Innovations:**

Collaboration with other UN agencies was increased during 2019 though co-location of premises and OMT Working Groups.
